Subject: Proposals for recognition of Electrohomoeopathy as a system of medicine. Matters relating to.

Sir / Madam,

Please refer to the 'minutes' of the meeting of the 'Inter-Departmental Committee for identifying viable new systems of medicine / therapy' (IDC), held in this Department on 09.01.2018, to consider proposals seeking recognition of 'Electrohomoeopathy' as a system of medicine, copy of which was forwarded to you under this Department's letter No. U-11018/02/2017-HR (Vol.III), dated which was forwarded to you under this Department's letter No. U-11018/02/2017-HR (Vol.III), dated which was forwarded to you under this Department's letter No. U-11018/02/2017-HR (Vol.III) among 19.03.2018. At the end of that meeting, all of you were advised by the committee to hold meeting among yourselves and then send a revised proposal, to facilitate further consideration of the case by the committee.

- 2. In view of the above, you are now requested to do the following:
- (i) All of you should immediately hold meeting (s) / consultation among yourselves (if not already done), and then, based on the discussions in the meeting on 09.01.2018, prepare a revised proposal on the subject for further consideration by the committee. In order to facilitate smooth interaction among yourselves, a mailing list, containing your addresses, etc. (as available in this Department's records) is enclosed (Annexure-I).
- (ii) For the sake of proper and correct appraisal of the issue, this revised submission should be in the form of only one combined, consolidated and unanimous proposal (*i.e.*, a joint proposal).
- (iii) Further, in order to facilitate proper evaluation of the viability of the Electrohomoeopathy system by the committee, this joint proposal should be prepared as advised in the meeting with authentic, standardised and purely scientific data / material, including books / publications

in journals / other references, etc., on the system of Electrohomoeopathy, specially those from India, expertise and institutions available in India and with all other information and documents on all related issues.

- It may be noted that since the committee will consider the joint proposal only, there should not be any individual submission. Therefore, proposals / information / documents, if sent (iv) individually by any of you, are not to be taken cognizance of.
- However, the said joint proposal should be accompanied with an exclusive 'Annexure' of about 2 pages, in respect of your organisation, giving salient features about your establishment, its activities and its contributions, including any publications on the subject, and any other (v) relevant point not covered in the joint proposal (It means that the joint proposal should be attached with separate such annexures, one each for all of you).
- While the joint proposal may address the parameters indicated at para-4(a) of this Department's Notice, dated 28.02.2017 (uploaded on its website), it should also address each of the seven principles / criteria (as indicated in the Annexure-II to this letter), accompanied (vi) with supporting documents.
- The proposal should have a 'response section', containing your response to different comments made by the expert members of the committee in the meeting of the Committee, (vii) held on 09.01.2018.
- Individual proposals / references on Electrohomoeopathy, sent by you prior to the IDC meeting held on 09.01.2018, have already been considered by the committee. Therefore, your new and (viii) joint proposal, as mentioned above, has to be a fresh and self-contained one, and no references to your earlier individual references should be there.
- You are requested to submit the hard-copy of the joint proposal in duplicate, along with the 'soft copy' thereof in a 'Pendrive'. Subsequently, you may be required to supply more hard-(ix) copies, for which intimation may be sent to you in due course.
- It may be noted that unless and until you submit the joint proposal in the manner as advised above, it may not be possible for the committee to appraise your proposal properly. Therefore, in the interests of proper and meaningful appraisal of your proposal, the committee would expect your positive cooperation in the matter by way of your strictly complying with the advice of the committee. It may be appreciated that not complying with the above advice strictly, will only help in delaying the process, and defeating the purpose.
- Lastly, and importantly, in order to facilitate the combined approach, as mentioned above, it may be advisable for all of you to nominate a small body of individuals, who may submit the said joint proposal and documents on behalf of all of you, and who can represent you before the committee, if required by the latter. Further, for the sake of transparency and fairness in the matter, it may be advisable that your letter to this Department - nominating the said body of individuals - may be jointly signed by at least one person on your behalf. Alternatively, your letter, forwarding the joint proposal to this Department, may be jointly signed by all of you. It may also be noted that once you nominate the body of individuals, and intimate about it to this Department, future correspondence in the matter will be made by this Department with that body only.
 - You may now take expeditious action in the matter, and arrange to submit the joint proposal, prepared in the manner as advised above, to this Department - in duplicate, along with the soft copy in a pendrive - at the earliest, preferably within a period of one month. ours faithfully,

PRINCIPLES / CRITERIA

Essential Criteria

- The system should have its own fundamental principles of health and disease, which must differ in concepts from those of recognised systems in the country. It should be a comprehensive system of health care and not restricted to few diseases only.
- 2. Substantial literature on concepts, aetiology, diagnosis and management of diseases like textbooks including Pharmacopoeia and Formularies and preferably journals if any, should be available in the country of origin or in other countries where it is currently practised.
- 3. Information on whether it is recognised officially as a system of medicine in the country of origin and / or in any other country, where it is currently practised.
- 4. Documented information on uniqueness of modalities of treatment may be drugs, devices or any other methods such as diet, massage, exercise, etc.
- 5. Standardised methods of preparation of Drugs / Devices used in the therapy and quality control procedures should be available.

Desirable Criteria

- 6. Prescribed criteria for admission, curricula and training and details of such courses and list of teaching institutions in India / countries where it is a currently recognised system of medicine.
- 7. Details of continuing medical education programmes and available research facilities.
